GOVERNOR PROCLAIMS APRIL "FINANCIAL LITERACY MONTH"

IDAHO DEPARTMENT OF FINANCE AND THE IDAHO FINANCIAL LITERACY COALITION OFFER MONEY SKILLS PRESENTATIONS TO THE COMMUNITY

Boise, Idaho . . . In an effort to promote financial literacy, Governor Dirk Kempthorne has proclaimed April to be "Financial Literacy Month". The Idaho Department of Finance and the Idaho Financial Literacy Coalition (IFLC), an affiliate of the Jump\$tart Coalition for Personal Financial Literacy, sponsor "Financial Literacy Month" in April. The IFLC is a partnership of private and public sector financial educators. The Department of Finance participates year round in the efforts of the IFLC and is proud to take part in this opportunity to draw attention to the need for all Idahoans to obtain basic money management skills. A press conference, sponsored by the IFLC, is scheduled for April 11, 2005 at 10:00 a.m. on the front steps of the Idaho State Capitol, featuring Congressman Butch Otter and representatives of the IFLC and Department of Finance.

In support of financial literacy, the Department is offering basic personal finance presentations throughout the year to Idaho high schools and senior citizen centers throughout the state. In addition, Department staff and IFLC members will be giving presentations to local community and senior citizen centers on a variety of financial topics during the month of April. These topics will include:

- Budgeting;
- Developing Effective Spending Habits;
- Managing Credit;
- Identity Theft;
- Phishing; and
- Securities and Investing.
