## SCAM JAM COMING TO MCCALL APRIL 21

Idaho Department of Finance Joins Forces with the Idaho Commission on Aging and the Idaho Scam Jam Alliance for this Free 2016 Conference

Boise, Idaho .... The Idaho Department of Finance is co-sponsoring Idaho's 2016 McCall Scam Jam Conference on Thursday, April 21<sup>st</sup> at **Idaho First Bank**, **475 East Deinhard Lane**, **McCall**, **Idaho**. This popular conference, the first of four to be held in Idaho in 2016, will host a variety of topics, including information on preventing financial fraud including investment fraud and identity theft avoidance tips.

The Idaho Scam Jam Alliance is a broad based coalition of non-profit organizations and state agencies with the goal of educating and arming the public with the tools they need to identify and stay protected from fraud and identity theft.

Doors will open at 8 a.m. and the conference kicks off at 9 a.m. with opening ceremonies conducted by **Master of Ceremonies Sherry Maupin, Vice President/Branch Manager of Idaho First Bank.** The keynote speaker for the event is **AARP Idaho State Director, Lupe Wissel.** The conference runs until 3:45 p.m., when there will be a drawing for door prizes and includes a complimentary lunch and refreshments.

The sponsors and supporters that have joined together to offer this free Scam Jam Conference include, the Idaho Department of Finance, the Better Business Bureau (BBB), the Idaho Department of Insurance, SHIBA, the City of McCall, the American Association of Retired Persons (AARP), Justice Alliance for Vulnerable Adults (JAVA), Idaho Legal Aid Services, Inc. (Boise) and local host Idaho First Bank. The conference is primarily funded through a grant obtained by the Idaho Commission on Aging's Senior Medicare Patrol Program.

The Scam Jam will address Medicare fraud, financial scams, and tips on how to avoid being a victim of identity theft. Attendees will also learn how to recognize and avoid exploitation that can jeopardize their financial future. Department of Finance Securities Bureau Supervising Investigator, Coleen Hodson, will offer a presentation on *The Chilling Effects of Investment Fraud* during a breakout session. The department also will have a booth where attendees can receive free educational information on investment, mortgage, cybersecurity, and consumer finance.

In addition to the Department of Finance's participation, experts presenting at the conference include representatives from the McCall Sheriff's Department, the McCall Postal Inspector, and the Idaho State Tax Commission.

The McCall Scam Jam is the first of four fraud prevention conferences being conducted by the Idaho Scam Jam Alliance. Conferences planned in 2016 will be in Coeur d'Alene on May 19<sup>th</sup> and two fall Scam Jams that are currently in the planning stages.
